STATE LIBRARIAN RETIRES

Estellene P. Walker, South Carolina State Librarian, has announced that she will retire on June 30. Miss Walker has headed the State Library Agency since 1946. The State Library is the agency responsible for the extension and improvement of library service in the state. Under her administration, statewide public library service has been established giving all the people of the state direct access to library service in rural as well as metropolitan areas. In 1946, forty-four percent of the state's population had no library service, but today that figure is zero. Also, total book holdings in the state have risen from 650,000 in all of South Carolina's public libraries to nearly four million today. The per capita bookstock increased from .3 to 1.46, which was achieved during a population increase of 36 percent.

A native of Virginia, Miss Walker graduated from the University of Tennessee and earned a graduate degree in library science from Emory University two years later. She is past president of both the South Carolina Library Association and the American Association of State Libraries. She is listed in Who's Who in America.

Miss Walker will continue to live in Columbia.

Miss Walker will be succeeded as State Librarian by Betty E. Callaham, who is currently serving as Deputy State Librarian, according to Dr. Carlanna Hendrick, Chairman of the State Library Board. Miss Callaham, a native of Honea Path, is a graduate of Duke University and holds master's degrees in both History and Librarianship from Emory University. Very active professionally, Miss Callaham was Coordinator for the Governor's Conference on Library and Information Services which was held in Columbia, March 15-17, 1979. She will be one of South Carolina's representatives to the White House Conference on Library and Information Services to be held in November of this year.

Joining the State Library in 1961, Miss Callaham was Director of Field Services from 1965 to 1974 when she became Deputy Librarian. She is listed in the eight edition of Who's Who of American Women.

The South Carolina Library Association wishes Miss Walker many happy years of retirement, and sends Miss Callaham congratulations and best wishes on her new post.

Executive Secretary's Report (Lou Whitmore) - Updated as of June 6:

- 676 Personal/Individual Members
- 46 Institutional Members
- 63 Honorary Life Members
- 785 TOTAL

These figures reflect both good news and bad news.

The good news is that despite the increased dues, our membership is at about the same level as this time last year. As the result of an informal membership drive, 109 of the personal members are NEW members.

The bad news is that our total membership at the end of last year was:

- 843 Personal Members
- 47 Institutional Members
- 65 Life Members

Our special concern is that 292 members from last year have not as yet renewed their membership. Because of many activities during this year, we want to encourage former members to renew their membership as early as possible.

Reports from Sections and Round Tables:

<u>Public</u>: Mrs. Norris Wooton gave a brief report on the Library Management Workshop sponsored by the Public Library Section along with the Library Education Round Table and the Library Administration Section as co-sponsors.

School: Mrs. Etrulia Dozier stated that Mrs. Laura D. Blanchard, Children's and Young People's Department, Charleston County Library will conduct a workshop at the SCLA Convention at Charleston in October. Mrs. Sadie Oglesby, retired English/Latin teacher presently part-time with Charleston TV Channel 5's "Scrapbook", is a possible speaker at one of the School Section meeting at the Convention.

Special Libraries: Mr. Dan Festa reported that the section is compiling a directory of special libraries in the State. He also reported that the Section in coordination with Ms. Susan Roberts, Continuing Education Committee, is planning a workshop for the Convention with Barbara Conway, Consultant, as main speaker.

Trustee: Mrs. Ruby Crook outlined a project under which trustees from small libraries would meet in a discussion session on problems facing those libraries. Assistance has been requested of Mrs. Alice Nolte of the State Library.

Library Administration: Mrs. Robin Mills reported that a Section meeting during the SCLA Convention will probably focus on the rights of handicapped.

<u>Public Services</u>: Miss Ilene Nelson reported on the successful workshop on Developing Library Sign Systems which was held on April 19.

On-Line Users Interest Group: Miss Nelson and Mr. Michael Havener spoke on forming an On-Line Users Interest Group within the Public Service Section. The purpose of South Carolina Librarians interested in planning, managing, teaching, and/or conducting computer based reference services in libraries.

It was noted that the By-Laws, Article VI, Section 2C, provides for subdivisions within a Section. There are no provisions for additional dues; however, it was recommended that the By-Laws of the Public Service Section be changed to provide for an On-Line Users Interest Group as a subsection to the Section. Financial support for the group, however, would come from the Public Services Section.

Technical Services: Mr. Frank Hite reported on the workshop on "Automated Acquisitions: How? When? Why?" held April 17 at Carolina Townhouse in Columbia.

Sara Gable, University of South Carolina, School of Medicine Library; Marjorie A. Mazur, South Carolina State Library; and Bud Walton, Thomas Cooper Library, University of South Carolina were nominated to attend the ALA/RTSD Introductory Program on the Anglo-American Cataloging Rules, Second Edition to be held as a preconference in Dallas. If these participants attend they will later conduct workshops on AACR2.

Library Education Round Table: The LERT plans a one-hour discussion at the SCLA Convention on the topic "How Library Educators Can Keep Abreast of Contemporary Developments."

Government Documents Round Table: Mrs. Frances Ellison reported that Mr. LeRoy Schwarzkopf, Documents Librarian from the University of Maryland, will be the Convention speaker for GODORT. In addition, a workshop is planned for September. The second GODORT Newsletter has been mailed to members of that Section.

ALA Councilor: Miss Betty Callaham reported on meetings of Association presidents, chapter councilors and other office holders to discuss matters of mutual interest.

She also reported that as a result of the Association-wide vote, the next ALA Mid-Winter Conference will return to Chicago.

SELA Representative: The position of Executive Director and Assistant Director of SELA are being discontinued as of June 30, 1979, with the activities of the office run by a part-time Executive Secretary after that date.

Standing Committee Reports:

Editorial: Mr. Larry Mitlin, Editor of The South Carolina Librarian, asked if Convention Sections' and Committee reports and annual reports should continue to be published in The South Carolina Librarian. The Executive Board voted that these reports should continue but that the editor have the right to summarize or condense the reports. The official report in the full version will be in the files of the Section.

News and Views Editor: The Executive Board officially appointed Mr. John Sukovich the Editor of News and Views. It was noted that this publication will require a minor change in the Constitution. The Board also voted to mail Edition 3 of News and Views to active, former and prospective members of SCLA.

1980/81 Convention: The 1980 SCLA Convention will return to Columbia with the joint North Carolina/South Carolina Library Association Convention scheduled for Charlotte, North Carolina in 1981. The next joint Convention, should there be one, will be held in South Carolina.

Publicity and Awards: It was recommended that the Association sponsor an award for a library school student. This suggestion has been turned over to the Publicity and Awards Committee for consideration.

To assist in public relations matters, the Executive Secretary has been provided a listing of all newspapers in the state. Publicity matters which have been coordinated with the Publicity and Awards Committee can be forwarded to her for release.

Planning Committee: The Board recommended that those resolutions of the Governor's Conference on Libraries and Information Services which require action by SCLA should be sent to the Planning Committee for study on methods of implementation.

Continuing Education Committee: The Executive Board recommended that the "Certificate of Attendance" (at workshops, seminars, etc.) and that CEU credits receive further study by the Library Education Round Table and the Continuing Education Committee before implementation.

The next SCLA Board Meeting is scheduled for August 25 at the Richland County Library. Members are urged to attend.

STATE LIBRARY-RELATED LEGISLATION

Jan Buvinger reports that state legislation is apparently stalled on all fronts right now.

The Documents Center Legislation, H2389, was amended on May 29 to strike Item 10, which made provision for the exchange of documents with other states. As amended, it is on the House calendar with objections, and to date, has not had a second reading. S348, the Senate version of the same bill, passed the Senate and was moved to the House for approval. At present, it is in the House Education and Public Works Committee, and apparently will remain there.

Security legislation, S334, has been carried over to the Second Session on the technicality that it was introduced after the deadline for new legislation this session.

\$438, State Library Board Terms, introduced by Senator Tom Smith, passed the Senate and is now in the House Education Committee for consideration. This bill essentially lengthens and staggers the terms of Board members.

WORKSHOPS, LOCAL ASSOCIATIONS MEET

The automated acquisitions workshop, held in Columbia on April 27, drew some 60 librarians from around the state to hear a state of the art summary by Shirley Tarlton of Winthrop College, and presentations by Lenore Wilkas (Acquisitions Librarian at USC), Pat Shufeldt (Acquisitions Librarian at Greenville Public Library) and

representatives of Baker & Taylor, Bro Dart, Blackwell/North America, and the Appalachian Regional Computer Commission. The event was the first workshop to be sponsored by SCLA's Technical Services Division. Frank Hite, Chairman of the Division, reports that one of the interesting comments to come from the workshop was the agreement by vendors that their acquisitions systems are not the best route for libraries with a book purchasing budget of less than \$100,000 per year or a rate of acquisition of less than 10,000 volumes per year. Smaller libraries, vendors said, would be better off to go to local computers (on campus, in the case of colleges, or governmental in the case of public libraries.)

Mr. Hite also reports that the Technical Services Division will be doing a program on AACR II at the Charleston convention this Fall, but details of that program are not yet available.

The Piedmont Library Association met on May 23 at the Milliken Research Corporation. The thirty members who were present toured the plan, watched a demonstration of the Dialogue On-Line System in the library and were guest of the Milliken Corporation for lunch. At a short business meeting, Tom Gilson assumed the Office of President, Gene Elliott was elected Vice President/President Elect and Don Miles was elected Secretary/Treasurer.

The Technical Education College Learning Resources Association met at the Instructional Services Center of the University of South Carolina on May 4. After a short resume of activities within the organization, the members toured the Services Center and the State Library where they observed a SOLINET demonstration. Dan Koenig was elected President, Ann Burton was elected Vice President and Teri Epting, Secretary. The LTA's of this group met on May 11 at the Airport Campus of Midlands TEC in Columbia where they took part in a workshop on Training Library Work Study Students. New Board members of the Association are Angie Chambers, Melissa Surber and Nancy Taylor.

The Library Performance Measures workshop held May 16th was attended by sixty-five interested librarians from all parts of the state. The speaker, Glenn F. Miller of Orlando Public Library, proved to be informative, entertaining, challenging and often controversial. The Public Library Section urges all libraries that attempt any kind of user survey this summer or fall to report on the results at the October SCLA Convention!

Plans for a convention program entitled "Political Savvy for Public Librarians" are already underway. Watch for further details.

WORKSHOPS, MEETINGS & SUCH (FORTHCOMING)

President-elect John Landrum reports that Art Plotnik, editor of ALA's American Libraries will be featured speaker at the Friday evening banquet at the Charleston convention in October. Entertainment (of a nature as yet undisclosed by Mr. Landrum) is also scheduled for the banquet. Reports indicate that recent changes in the food service at the Francis Marion Hotel have been made, and the banquet promises to be very good.

John also wishes to remind convention-goers that Thursday evening, after the harbor boatride, will be free and open, and participants will be able to sample on their own some of the wide range of restaurants available in the port city.

Mrs. Frankie Cubbedge has reported that Dr. Frank L. Schick will speak at the College Section's meeting at Charleston. Dr. Schick is Chief, Learning Resources Branch, Division of Multi-level Educational Statistics at HEW, and will speak on some recent library surveys and the effect of the statistics collected by his and other divisions at HEW.

In elaborating on the report in the last issue of the Newsletter on the session he is planning for the convention, Dr. Charles Curran said that he hopes to establish a dialogue between practicing librarians and library educators on the needs of those in the field. Assisting Curran in preparations for the program are Gerda Belknap and Herb. Nath.

Susan Roberts reports that the Special Libraries JMRT, LAD, and the Continuing Education Committee will sponsor a pre-convention workshop on staff development, at which Barbara Conroy will be the featured speaker. Ms. Conroy is a private consultant for libraries, and deals primarily with staff development and continuing education. The workshop is scheduled for Thursday, October 11, but final details on time and location are not yet complete. Registration information is to be sent out in August.

October 10-12 The College of Charleston will sponsor the Southeastern Workshop on the Preservation and Conservation of Library Materials. Conducted by Mr. George Cunha, Director Emeritus of the New England Document Conservation Center, the workshop will feature lectures, discussions, and demonstrations covering the topics of: the history of paper and papermaking; enemies of library materials and their control; and repair and restoration practices. Librarians, archivists and book dealers are invited to attend. For further information, contact: Dr. Ralph Melnick, Archivist; The Robert Scott Small Library, The College of Charleston, Charleston, S. C. 29401. Participation is limited to 100 guests.

Following the Preservation Workshop, The College of Charleston Library Associates will host the First Southeastern Antiquarian Book Fair, October 12-14, featuring exhibitors from throughout the United States. Rare books, maps, prints and manuscripts will be available for purchase. The Gaillard Municipal Auditorium will be the setting for the Book Fair, two blocks from the Francis Marion Hotel. Librarians participating in the South Carolina Library Association Convention are invited to attend. There will be a preview and wine and cheese party Friday, October 12 from 7:30 p.m. to 11:00 p.m. Saturday hours are 10 a.m. to 6 p.m. and Sunday, 12 noon to 6 p.m. Admission fees: \$5 for Friday through Sunday; \$3 for Saturday and Sunday; \$2 for Saturday or Sunday.

Dr. Chuck Curran (USC College of Librarianship) has edited the Library Research Round Table 1977 Proceedings, which are papers presented at the ALA Convention in Detroit last year. Copies of the publication are available from University Microfilms.

Dr. Curran and Dr. Barron will be giving a paper at the upcoming ALA Convention in Dallas. Topic of the paper will be "Information Needs of Rural People." The paper will be given at the meeting of the Library Research Round Table Forum at 2 p.m. on June 26.
