THE LAW SCHOOL

The Law School has an enrollment for the Summer semester of a total of 231 students, 11 less than last summer's enrollment. It is of interest to note that, as of May, the average age of the whole student body of the Law School was 24 years; that 92 per cent were veterans attending under G. I. benefits; and that, of freshmen entering in February, 97 per cent were attending under G. I. benefits.

We have good reason for the hope that the new Law School building will be ready for occupancy by the beginning of the Fall semester.

Wig and Robe, the Law School honorary society based entirely on scholastic averages, announced the selection of seven new members, who signed the register at a Law Federation meeting on March 9. New members from the senior class were Hyman Fechter, Charleston, and John D. Horne, Loris. New members from the junior class were Raymond S. Interesting speakers heard during the Spring semester included Oscar H. Doyle of Anderson, District Attorney of the Western District of South Carolina; Thomas Boulware, Esq., of Allendale, an Equity and Property authority; J. Means McFadden, Esq., Attorney of Chester; and Judge Bond Almond, Judge of the Superior Court of Fulton County, Georgia.

On June 2, the outgoing and incoming officers of the Law Federation, the Honor Council, and the staff of the LAW QUARTERLY, were honored by Dean Prince at a supper at Wade Hampton Dormitory Cafeteria.

Beginning July 25 and continuing for eight weeks, the Law School is conducting a special course for lawyers in Federal Tax Practice. Classes will be held three days a week, Monday through Wednesday, 10:30 A.M. to 1 P.M. The instructor will be Howe P. Cochran, Esq., of the Washington and New York bars. Mr. Cochran has a marked ability at teaching and is one of the outstanding triers of tax cases in America. He has a sentimental attachment for the University, since his great uncle, William C. Preston, was at one time it's President.

This course is also open to the senior class, and 67 of them have registered for it. Many lawyers over the state have indicated that they would attend. At no other school in America can one attend a course of this type and calibre this summer.

Professor Coleman Karesh has just returned from Washington, where, during the latter part of May, he represented the Law School at the American Law Institute, which has for years been working on a Restatement of the Law, and has published many volumes of this restatement in many different fields.

The honorary degree of Doctor of Laws was conferred on Dean Samuel L. Prince by Wofford College at its commencement exercises on June 6. Dean Prince has accepted an invitation to attend the Judicial Conference of the Fourth U. S. Circuit Court of Appeals, to meet at Asheville on June 23-25.
