

Professorial Profile: Martin McWilliams

Martin McWilliams began
teaching law at the University
of South Carolina in the fall of
1983. His preparation for this
career, however, began many
years before during his second
year of law school at the
University of Mississippi.

At this time in McWilliams legal career, he decided that he wanted his career direction to be in the academic area. One of his law school professors advised him to get additional experiences in law in the form of an advanced degree (L.L.M.), a good judicial clerkship, and a few years practice at a Wall Street Law firm.

McWilliams had the good fortune to experience all three. He pursued his L.L.M. at Harvard Law School after graduating from Ole Miss. Two years later, he clerked for a Fifth Circuit Court of Appeals Judge, the late Honorable Robert Oinsworth.

The judicial clerkship provided McWilliams with a useful experience. He learned about an opinion's structure. This insight of how to read an opinion enables him to get a feel for what is important to judges.

After his clerkship, Davis Polk & Wardell employed McWilliams as an associate in their New York office. He worked his first three years in New York City and then transferred to the firm's London office for an additional three

Finally, McWilliams made his big move after interviewing with several Southeastern Law schools. The Mississippi man chose the University of South Carolina because of its location in a small Southern city, the school's need for a teacher in his area of interest, as well as the latitude this area offered, and a good library with research support.

Since he began teaching McWilliams has discovered that "Teaching is fun, more than I thought it would be." He explained his love of teaching. "A practicing lawyer spends much of his time proofreading, handling administrative tasks, advising clients in non-legal matters and doing things for a client that the client can do for himself." McWilliams would

rather work on pure legal problems in a school forum.

When asked how developed his teaching style, he responded that he has seen a lot of teaching from a student's point of view after ten semesters of Law school. He also served as an infantry officer where one of his duties was to convince and communicate. His private practice enabled him to develop his habit of explaining legal things. McWilliams believes there is for need always a improvement.

When McWilliams is not solving legal problems or

teaching classes, he can be found outside. He enjoys outdoor activities that include biking, fly fishing, skeet shooting, and bird hunting. He can also be found rooting for the Columbia Mets.

Hagood Lecture

Dr. Christopher J. Whelan, a professor at the Centre for Socio-Legal Studies, Wolfson College, Oxford, England, will speak on "The Magic of Law-Reconciling Military Intervention in Democratic Societies" at the ninth annual Benjamin Adger Hagood Lecture at the University of South Carolina School of Law Wednesday, March 6, 1985 at 7:00 p.m.

Whelan is the Strom Thurmond Distinguished Visiting Legal Scholar for the 1985 spring semester at the law school where he teaches a course in comparative labor law. He has taught at several British and American universities, and specializes in labor law, contracts, torts, corporate law, law and social policy, and alternative methods of dispute resolution. Whelan has done extensive research in the areas of private international law and law and economics.

Co-editor and co-contributor of Sociological Approaches to Law, Whelan has three more books forthcoming in 1985. He has written several articles, chapters in books, comments, notes, case notes, and other publications and has presented more than nineteen papers on such subjects as "The Law and the Use of Troops in Industrial Disputes," "Malpractice by Lawyers in England" and "Judicial Responses to Exchange Rate Instability."

Whelan received his LLB. Degree from the London School

of Economics and Political Science in 1973 and his Ph.D. from the same institution in 1980.

The Hagood Distinguished Lecture Series was established by the late James M. Hagood through the USC Educational Foundation. The gift was made in memory of his father, Benjamin Adger Hagood, a prominent 19th century Charleston attorney. This year's lecture will be delivered in the Strom Thurmond Auditorium of the law school.

Crime And Justice Lecture

Adam Bedau, Austin Fletcher Professor of Philosophy at Tufts University, will lecture on "Capital Punishment and Executive Clemency" Thursday, March 21, 1985 at 8:00 p.m. in the University of South Carolina Law School auditorium.

Bedau has written extensively on this topic and is considered an expert by persons on all sides of this issue.

This presentation is part of the "Crime and Justice Lecture Series: Legal and Philosophical Perspectives," sponsored jointly by the School of Law, the College of Criminal Justice, the Philosophy Department and the Provost's Office at USC. It is free and open to the public.

Law Week 1985

Law Week commences Monday, April 8, and this year's celebration includes two new events.

The SBA Law Week Committee tentatively plans to start the-week with a "Trivia Bowl", a take-off on the memorable "College Bowl" TV series. Panels of students and professors will compete in answering trivia questions, with the final round scheduled Monday night.

On Tuesday, April 9, the movie classic, "Anatomy of a Murder", will be shown in the Strom Thurmond Auditorium. Beer and popcorn, on the house.

The Annual Awards Ceremony follows on Wednesday, with a speech that evening by Stan Sporkin, general counsel for the Central Intelligence Agency, and a reception afterwards.

Thursday, April 11, features law school's answer to Saturday Night Live, the Law Follies.

The keynote speaker for the Law Banquete, Friday night, will be F. Lee Bailey. A 51 yearold Massachusetts native, Mr. Bailey attended Harvard and served in the navy and Marine Corps as a pilot before entering law school at Boston University in 1957. His early clients included Dr. Sam Sheppard and Albert DeSalvo, better known as the Boston Strangler. F. Lee Bailey (the F. stands for Francis) has also been censured by the Massachusetts bar and suspended for a year by the New Jersey bar. In his autobiography, "The Defense Never Rests", he claims a 60 to 70 percent acquittal rate, and a higher percentage with homicides. Mr. Bailey holds admittedly unorthodox views on law school and enjoys telling jokes, so the speech should be interesting, to say the least.

Saturday, April 13, marks the last day of Law Week, with the Law Day Run in the morning, and the First Annual Law Olympics scheduled to follow.

Bankruptcy Clinic Receives Grant

The Southeastern Bankruptcy Law Institute, Inc. has given a grant to the Bankruptcy Practice Clinic at the University of South Carolina School of Law.

The Institute is a nonprofit corporation organized for the primary purpose of presenting an annual seminar on bankruptcy law and rules. The Institute uses any excess funds from the seminar to support a variety of projects, including legal education, which will improve the quality of bankruptcy practice.

Two members of the Institute's board of directors, James C. Frenzel, a partner in the law firm of Womble, Carlyle, Sandridge and Rice in Winston-Salem, North Carolina, and the Honorable Dudley H. Bowen, Jr., U.S. District Court Judge for the Southern District of Geoirgia, made the presentation to Dean

Harry Lightsey during a ceremony at the Law School on January 18, 1985. Among those in attendance was The Honorable J. Bratton Davis, Bankruptcy Judge for South Carolina.

The Bankruptcy Clinic enables third-year law students to represent clients in bankruptcy proceedings from the initial client interview through the end of the case. Classroom meetings cover a variety of topics related to bankruptcy practice.

The grant will be used to hire an adjunct professor to teach the clinic with Associate Clinical Professor Lewis Burke and equipment and software to support the simulation of a case involving financial problems of a small business. This "Debtor Creditor Game" will represent the Law School's first experiment with computer-assisted legal instruction.

Legal Forum: General Donavan

First year law student David Reeder-Savage was awarded the Commandants Trophy for his outstanding achievements in the United States Marine Corps Officer Candidate School during a ceremony in the auditorium on January 23.

Brigadier General Walter J. Donavan Jr., Director, Judge Advocate Division, United States Marine Corps, was on hand to present the trophy to Reeder-Savage, who is a Marine Second Lieutenant after attending the OCS last summer.

Reeder-Savage, who had no prior military experience, is the first law student to receive the award, which is based on a potential officer's exhibited leadership, academic performance, and physical fitness.

In his remarks, General Donavan spoke briefly on the role of the lawyer in the marine corps.

"There are now 410 lawyers in the corps, and they have to attend thirty-one weeks of training, including training on the law of war," he said.

"Regrettably, most of our lawyer's work is in criminal law, but other fields such as environmental law are also brisk," he said.

The General added that wives, dependents, retirees, and civilians employed on the base are all entitled to legal assistance.

He also mentioned that all opportunities in the marine Corps are availabel for women, who now number 10,600 out of the total 197,000 persons in the Corps.

Genreal Donavan commended the USC Law School on its growing national reputation as evidenced by the recent appointment of Walter T. Cox to the United States Court of Military Appeals.



Asbestos Found in Law Center

Asbestos, a cancer-causing fibrous material used for controlling and containing heat, has been found in structural steel in the Law Center. David Rinker, vice-president in charge of facilities, came to the law school on Monday, February 11th to answer questions.

Rinker, who said there was no immediate danger, explained the possible procedures for removal of the asbestos. The insulation may be taken off the steel, and then the pipes would be re-sprayed, or the asbestoscovered pipes may be encapsulated. At the present time,

research is being done to see if the latter approach is the best method.

No matter which alternative is chosen, Rinker warned of possible displacement of some areas while the work is done. He added that certain areas may be taken care of without any disruption. Explaining that it would be best to proceed with work when the building is not in use, Rinker said removal would not begin until the summer.
