BERKOVE, Lawrence I. Is Professor of English and American literature at the University of Michigan-Dearborn. His primary field of interest is American literature of the nineteenth and early twentieth centuries. He has published articles on Whitman, Twain, Bierce, Cable, and Hawthorne, and is presently completing a book on Bierce.

CAIRD, James B. Graduated with First Class Honors in English at Edinburgh University (1935 Vans Dunlop Scholar), then spent a year at the Sorbonne. Taught in various schools in Scotland, before becoming one of Her Majesty's Inspectors of Schools (1947-74) finally being in charge of Ross and Cromarty District in the Highlands. Has published poems, reviews and critical articles in a number of periodicals and critical symposia. Until 1978 was Vice-President of the Association of Scottish Literary Studies.

CAMPBELL, Ian. Lecturer in English literature at the University of Edinburgh, and active there in the teaching of Scottish literature. One of the editorial team of the Duke-Edinburgh edition of the Carlyle Letters; has published *Thomas Carlyle* (1974); at work on a number of projects on Carlyle, on nineteenth- and twentieth-century fiction in Scotland, and in history of science.

- FULTON, Henry L. Professor of English, Central Michigan University. Research in both Shakespeare and various aspects of eighteenth-century Scottish culture. Currently at work on a biography of Dr. John Moore (1729-1802), Scottish physician and novelist, correspondent of Smollett and Burns.
- GAMERSCHLAG, Kurt. Professor at the University of Bonn, author of a comprehensive research-survey of Scott studies and an analysis of Scott's and Ballantyne's proofreading, *Sir Walter Scott und die Waverley Novels* (1978); *Die Korrektur der Waverley Novels* (1979). At present working on an edition of *Count Robert of Paris* and post-romantic narrative verse.
- GIFFORD, DOUGLAS. Is a member of the English Department at the University of Strathclyde where he teaches a course on the Scottish novel. Has edited *Scottish Short Stories*; James Hogg's *Three Perils of Man*; James Hogg: *New Assessments*; and with Alexander Scott Neil M. Gunn: *The Man and the Writer*. Has appeared frequently on radio programs about literature and the other arts in Scotland.
- GOULD, Christopher. Ph.D. University of South Carolina which included a complete descriptive bibliography of the 130 known imprints of the Robert Wells firm of Charleston. Has published an article concerned with the colonial book trade in Charleston (*South Carolina Historical Magazine*) and is presently compiling a complete descriptive bibliography of South Carolina imprints, 1731-1800, which is to be published by the University of South Carolina Press.
- JAMIESON, Ian. Senior Lecturer in English at Victoria University of Wellington, New Zealand. Has recently returned from a year as a Visiting Fellow in the Institute for Advanced Studies in the Humanities of the University of Edinburgh, where he continued his work on Middle Scots poetics.
- KINGHORN, A. M. Educated University of Aberdeen and Pembroke College, Cambridge; previously Professor of English, University of Aarhus, now Professor of English in the new University of Qatar, Arabian Gulf; member of editorial board of *SSL* since 1964. Co-editor of Vols. III-VI of STS edition of Allan Ramsay's *Works* and of *Poems by Ramsay and Fergusson*. Also author of *Mediaeval Drama* (1968), *The Middle Scots Poets* (1970), *The Chorus of History 1485-1558* and of many periodical articles in *MLR*, *Neophil*, *REL*, *ES*, and *SSL*.

- MARX, László. Graduate of Eötvös Lóránd University, Budapest, in Hungarian and English literature and linguistics. In 1978-79 completing pedagogies and education diploma. Has published criticism on modern Hungarian poetry and drama; at present working on Burns.
- SCHEPS, Walter. Is Associate Professor of English and Comparative Literature at SUNY, Stony Brook. Most of his previous publications are on Chaucer and the Scottish Chaucerians.
- SCHRADER, Richard J. Ph.D. from Ohio State, Associate Professor of English at Boston College. Has edited the *Reminiscences* of the Scottish scholar Alexander Dyce, and has published articles in the *Chaucer Review*, *Classical Folia*, *Comparative Literature*, *Renascence*, *The Journal of Medieval and Renaissance Studies*, and elsewhere.
- SCHWEITZER, Edward C. Associate Professor of English, Louisiana State University, Baton Rouge. He has published essays on Old French, Middle High German, and Middle English literature, and his current research concentrates on Chaucer and Langland.
- SCOTT, Alexander. One of the most prolific of Scottish writers, as poet, dramatist, critic and editor. Among other functions he is a member of the Council of the Scottish Text Society; a member of the Literature Committee, Scottish Arts Council; a member of the British Council; and a Trustee of the Hugh MacDiarmid Memorial Trust. No collected edition of his poetry exists, but *Selected Poems 1943-1974* was published in 1975. In addition to all his other activities he is Head of the Department of Scottish Literature at the University of Glasgow.
- SROKA, Kenneth M. Is Associate Professor of English at Canisius College, Buffalo, N. Y., where he teaches courses in Victorian Literature and the English novel. He is currently at work on a book-length study of Scott's Waverley Novels.
