

## Williams Announces **New Placement Policy**

In a sweeping stroke of magnanimity, Placement Director Sharon D. Williams announced a new policy forbidding any students from hoarding job offers. Williams said that ideally no student would be allowed two job offers until all the students had at least one offer.

"It hit me like a bolt of lightning," Williams said of her new policy. "I mean, golly doodle, all of our students are qualified, and the students with the best grades are hoggin' up all the offers. It just didn't seem fair."

Williams further explained that it seemed particularly unfair for the students with the best grades to receive multiple job offers when everyone knew that grades were determined by the stair upon which an exam fell. The new placement policy is tentatively named "Job Equalization."

Williams' guidelines for Job Equalization include a minimum salary offer of \$48,000 per year with a \$3000 signing bonus. Says Williams of the minimum salary, "If one of 'em can pay it, they can all pay it."

As for the mechanics of Job Equalization, Williams compared it to the childrens' card game of Spoons. Says Williams, "Say for example, Student X, who we'll call Luke, gets his first offer. He will keep that offer. But if he gets another offer he must either give up the first offer to keep the second offer, or just pass along the second offer to someone we'll call, strictly for the purpose of this hypothetical, Jim Rogers. In

this manner, job offers are circulated through all the students."

Violations of Job Equalization will be handled by the Honor Council, although punishment for violators will be determined in a more creative fashion. Says "Any student Williams, discovered hoarding offers will regret the day his parents ever entered puberty."

#### **Environmental Law Society Plans Speaker's Program**

The Environmental Law Society (E.L.S.), was formed to provide students with an opportunity to become familiar with environmental programs, concerns and litigation within the legal field.

The group will sponsor monthly speakers, the first of which was held September 21, featuring Karen Crawford of Nelson, Mullens, Riley and Scarborough. Ms. Crawford spoke on the topic of "Environmental Concerns in Property Transactions."

The remainder of the fall semester will feature speakers discussing the Coastal Council Rules and Regulations and the impact of these regulations on developers and private landowners. During the spring semester the group will feature various state, corporate and private attorneys speaking on hazardous waste concerns.

Also during the spring semester, the E.L.S. will conduct an Environmental Law Moot Court Competition. The winners of this competition will receive a monetary prize and will be judged by a nationally

known environmental attorney. Additional activities of the society include a monthly newsletter, ENVIROLAW; publication of the national newsletter for Environmental Law Societies, (E.L.S.E.), sponsorship of field trips (a visit to the Ridgeway Mining Co. is tentatively scheduled); and participation in Pro Bono activities related to environmental law.

Membership is open to all students. Attendance at one meeting per year is re-quired for membership, with attendance at two meetings required to vote in the spring.

This year's officers include Gwenn Geidel president; Beth Council - vice president; Ken Mittledorf - secretary; Steve Rodenberg - treasurer; and John Buckley - past president.

#### Moot Court Bar **Explains Second-**Year Competition

The Moot Court Bar of the University of South Carolina is an oral advocacy organization whose members are chosen each year from the second-year class. Twenty-three members currently com-



prise membership in the Moot Court Bar, selected through competitions requiring a written brief and two rounds of oral argument.

This fall, the Bar has developed a hypothetical appellate case with two distinct issues, certain that neither issue is one-sided. The record of the case will be distributed to those members of the secondyear class who wish to compete. Having chosen partners, each team is assigned to represent either appellant or respondent.

Each team must then submit an appellate brief, with each team member responsible for writing the portion of the brief dealing with one of the two issues. Following the submission of briefs, two rounds of oral argument are conducted, with those competing each arguing twice. Oral arguments are judged by local attorneys, with the top 20 to 25 people selected for membership in the Moot Court Bar. Membership is contingent upon arguing in the spring semester.

During the spring semester, all newly selected Moot Court members argue the same problem with the results based entirely on the oral arguments. The four top scoring participants are named as captains of the interscholastic teams which represent the law school. Additionally, the top two oralists from the Spring round for each issue are annually invited to argue the hypothetical case before the South Carolina Supreme Court. After arguments, the Court issues a decision and selects the best oralist. At this time, members of Moot Court Bar are sworn into membership

before the Justices of the State Supreme Court

The Moot Court Bar fields four interscholastic teams. The ABA team, the Craven team and the National team, each consisting of three members. The International team has four members. In the past few years, teams fielded by the Moot Court Bar have travelled to many locations around the country and have been very successful

The Palmetto Law Society is one of three law fraternities at the USC School of Law. Formerly Delta Theta Phi Law Fraternity, the group was reorganized in the Spring of 1988 in order to become a local organization.

First time offenders will have a choice of punishment. They must either 1) be a Public Defender in Conway, 2) be a legal research assistant for Eldon Wedlock, or 3) be a referee for the law school basketball league. Length of sentence is determined by the Honor Council, but it cannot exceed one year.

Repeat offenders will be placed with a prominent law firm in Barnwell headed by a gentleman well respected across the state. The sentence cannot be less than five years, during which time the violator is required to swear that he loves his job. Says Williams, "I feel certain that this will discourage any violations."




