- BURLING, David. Assistant Professor of English at Auburn University. Is the author of articles and reviews on Fielding, eighteenth-century drama and fiction, and the Cibbers, published or forthcoming in *Philological Quarterly*, *Modern Philology*, *Novel*, *Theatre Notebook*, *English Studies*, and elsewhere.
- DANZIGER, Marlies K. Professor of English at Hunter College of CUNY. She is editor, with the late Frank Brady, of *Boswell: The Great Biographer*, James Boswell's last journal, to be published shortly by McGraw-Hill as part of The Yale Editions of the Private Papers of James Boswell.
- FULTON, Henry L. Professor of English at Central Michigan University and Director of International Programs. He writes on both eighteenth- and twentieth-century Scottish literature and is currently finishing a biography of John Moore.
- GELDER, Kenneth. Teaches in the English Department at La Trobe University, Melbourne. Has recently edited a collection of Stevenson's Scottish stories and essays to be published by Edinburgh University Press. Is also writing a book on recent Australian fiction.
- GROVES, David. His most recent book is *James Hogg: The Growth of a Writer* (1988). His more than seventy articles on James Hogg have appeared in the *Wordsworth Circle*, *Library, Notes & Queries*, *The Bibliothek*, *SSL*, *Scottish Literary Journal*, *Scottish Studies Newsletter*, *Chapman*, *Newsletter of the James Hogg Society*, and elsewhere. Currently working on a study of Thomas De Quincey as an Edinburgh writer.
- HILLIER, Robert I. Assistant Professor of Education at the University of Hawaii at Hilo. Previously English teacher at Hilo High School and a Peace Corps Volunteer in ESL in the Philippines. BA in History from Haverford College; Ph.D. in English from the University of New Hampshire.

JONES, Douglas. Research student at the University of Virginia; BA from the University of Chicago; MA from Virginia. Author of several plays; currently adapting Gogol's *The Nose* for the stage.

KRISHNAN, R. S. Assistant Professor of English at North Dakota State University, specializing in eighteenth-century British literature and critical theory.

LONG, Eugene Thomas. Ph.D. from the University of Glasgow. Professor of Philosophy at the University of South Carolina. Author or editor of six books and many articles on the philosophy of religion, phenomenology and existential philosophy. Publications include studies of the Scottish philosopher and theologian John Macquarrie, and the Scottish theologian Ronald Gregor Smith.

MACAULAY, Ronald K. S. Native of Ayrshire; MA from St. Andrews, Ph.D. from UCLA. Professor of Linguistics at Pitzer College. Taught for the British Council in Portugal and Argentina before coming to California. Has published a sociolinguistic study of Glasgow speech and is working on a study of the dialect of Ayr.

MANLOVE, Colin. Reader in English Literature at the University of Edinburgh. He is the author of *Modern Fantasy* (1975), *Literature and Reality 1600-1800* (1978), *The Gap in Shakespeare* (1981), *The Impulse of Fantasy Literature* (1983), *Science Fiction: Ten Explorations* (1986), and *C.S. Lewis: His Literary Achievement* (1987). Has recently completed a book on techniques for thinking about literature, entitled *Thinking About Books*.

WATSON, Roderick. Ph.D. from Cambridge on Hugh MacDiarmid. Senior Lecturer in English at the University of Stirling. Has published essays on Carlyle, Edwin Morgan, Nan Shepherd, and a critical guide to Norman MacCaig's poetry. Is the author of *The Literature of Scotland* (1984) which unites Gaelic literature with works in Scots and English.

WHYTE, Christopher. Studied at Pembroke College, Cambridge, and at the University of Perugia. Taught for eight years at Rome University before returning to Scotland where he lectures in the English Literature Department of Edinburgh University. He is a poet, translator and a critic in English and Gaelic.

WILLIAMS, David. Senior Lecturer in English at Bulmershe College of Higher Education, Reading. Has degrees from the Universities of Hull and Oxford, and has published articles on contemporary British, Irish, and American poetry.

ZAGNOLI, Marco. Degree in modern languages and literature from the University of Bologna. Graduate diploma from that university with research on the theory of literature and the technique of literary criticism. Thesis on the work of George Mackay Brown. Teaches English language and literature at the Liceo Sperimentale Ariosto in Ferrara.
