New College of Charleston Marlene and Nathan Addlestone Library — The building should be complete next spring, and it will be spectacular. Now that the framing is in place and the windows are installed, there is a true sense of the grand spaces and interior layout. The columns around the three-story rotunda will glow with a warm cherry wood paneling. The electronic reading room is a lofty two-story space where students can log onto 130 computers. There are 20 study rooms where small groups can work together. With wireless access to the Internet, students can log on from anywhere in the building or

ASERL Launches Shared Chat Reference Service Linking Users to Staff at By 10 ASERL Libraries

On July 1st, the Association of Southeastern Research Libraries (ASERL) officially launched development the first phase of a unique cooperative virtual reference service, the first of its kind in the country. When the system goes live in January 2004, it will be the first chat Web-based reference service supported by research library staff across a region of the country.

"This is an exciting time for ASERL, and one of our most ambitious projects ever," commented John Ulmschneider, University Librarian at Virginia Commonwealth University and chair of ASERL's project development Virtual Reference team. "It builds on a successful history of pioneering ASERL projects, from the founding of SOLINET to the innovative Kudzu interlibrary loan network. We're thrilled to have ASERL undertake this ground-breaking initiative in this emerging field of library practice."

Participating libraries include College of William & Mary (Williamsburg, VA), Florida State University (Tallahassee), University of Alabama (Tuscaloosa), University of Central Florida (Orlando), University of Kentucky (Lexington), University of Louisville (KY), University of Memphis (TN), University of North Carolina at Charlotte, Virginia Commonwealth University (Richmond), and Wake Forest University (Winston-Salem, NC).

"We are fortunate to have such a great group of research libraries collaborating in this innovative effort," commented Derrie Perez, ASERL Board President and Interim Dean of Libraries at the University of South Florida. "These ASERL members participants bring a broad array of expertise and experience, offering a wonderful opportunity for our students, faculty, and scholars to interact with great libraries across the region."

ASERL's cooperative virtual reference system The new system will allow ASERL library patrons to use chat software to get reference help from research library experts, seven days a week, 12 hours a day, with service hours added if there is demand. "We examined the usage levels of existing 24/7 online services – which are low – and decided to start with 12/7 initially," commented Ulmschneider. "We can always add hours to the service in the future if there's a demand for it."

ASERL's cooperative virtual reference system will use OCLC's QuestionPoint software, selected after a study of 10 similar packages. "We're pleased ASERL has selected Question-Point to be the backbone of their new service. We look forward to working with ASERL to get the project launched and showcase the capabilities of QuestionPoint," commented Frank Hermes, OCLC's Vice President for Cooperative Discovery Services.

Winthrop's Dacus Library Media Services Digitization Project

ROCK HILL, S.C. - More than 25,000 photographs, maps and postcards will be available to Winthrop's Dacus Library patrons over the next few months as staff members and students make the pictures available online.

"Most of these items are from collections that haven't been seen until now," said Mark Herring, dean of the Dacus Library at Winthrop University. "Because we have such a small archives staff, we couldn't provide a lot of public access, and people had to know what they were looking for."

Herring expects there will be much interest in this new online service from researchers, genealogists and historians.

Winthrop's archives are filled with materials relating to the Catawba Indians, pre- and post-Civil War photographs and women's history in Southern states. It also has nearly 200 glass photo plates of Rock Hill and York County dating back to the 1800s from one of the country's earliest commercial photographers, John R. Schorb of Yorkville, now York. Two grants from the Lutz Foundation of Chester for \$5,000 and for \$12,000 and a \$4,051 grant from the Knapp Foundation of St. Michaels, Md., supplied much of the money needed for equipment purchases. The grant money purchased computer memory, a high quality scanner and Millennium Media Management software, which totaled more than \$25,000. While the equipment allowed for the actual digitization of the images, the software allows for their display in the library's online catalog. The two features together provide cutting edge technology in the area of archival digitization and display. Digitization will help save an image of the documents, many of which are on wood pulp paper and have a limited life, Herring said. Also, digitization is superior to microfilm, he said, not only because it replicates a copy with finer detail, but also because it makes its reproduction immediately available to anyone online who has a Java browser.

Dacus Library started the digitization project in 2000 and will finish around 2005 or 2006. Already, part of the Schorb collection and historic photographs of Winthrop buildings are online.

With this digitization equipment purchase, Dacus Library joins the ranks of the premier archives collections in the country. To date, only 116 libraries in North America have the capability to digitize and then display thumbnails on their online catalogs.

There will be a cost to download the photographs for use in publications. ASERL, SOLINET, and HBCU Library Alliance Co-Host National Diversity Conference to Focus on Library Staffing, Collections

The fourth National Diversity in Libraries Conference will be May 4 and 5, 2004, in Midtown Atlanta. This conference is co-sponsored by the Association of Southeastern Research Libraries (ASERL), the Southeastern Library Network (SOLINET), the Historically Black Colleges and Universities (HBCU) Library Alliance, and the Association of Research Libraries (ARL), and will serve as a pre-conference for SOLINET's 2004 Annual Conference.

The 2004 Diversity Conference feature will speakers and discussions designed to foster improved diversity within a broad range of libraries, including large research libraries, small and mid-sized college libraries, and public libraries. The agenda will examine two main issues: how to promote diversity among library staffing, and how to develop collections that reflect the experiences of a diverse community.

"By focusing on realworld examples, we'll give participants the tools they will need to implement new diversity programs at their own institutions," said Derrie Perez, ASERL's Board President and Interim Dean of the University of South Florida Library System. "This is especially relevant because finding qualified librarians and staff to fill open positions is difficult due to dropping enrollments at library schools across the country."

from the spacious park. The tables and study carrels will be crafted from cherry wood – they are designed as classic pieces that should withstand many decades of use. Students and faculty will find three types of chairs – ergonomic seats while they work at computers, traditional wooden library seats and comfortable lounge seats near the current periodicals and around the rotunda. There will be seating for 1,500 students, faculty and visitors and capacity for 1,000,000 volumes. The Park will extend from the south side of the Streets. There will be large expanses of green space and large shade trees around the perimeter of the park dotted with benches and tables. It is expected that the multi purpose space will be in great demand for informal gatherings and a wonderful site for major College events. Photographs

Medford Library Expansion, USC Lancaster — The University of South Carolina at Lancaster held a groundbreaking on Friday, August 24, for a \$4 million Medford Library expansion to add 24,000 square feet for library collections and technology. The program included remarks by Mr. Billy Boan, Chief of Staff for Governor Jim Hodges, Mr. James Bradley, member, USC Board of Trustees, and other representatives of the University of South Carolina. The public joined USCL students, faculty, and staff for the occasion. "This new library space," said Shari Eliades, director of the Medford Library, "provides another dimension to the academic life of our campus. It will serve as a place where students can study and conduct research, where the newest information technology will be available, where the faculty materials can and will be preserved, and where the faculty

and community can avail themselves of the University's resources."

The addition of 24,000 square feet is expected to double the library's functional space. The additional space will be used for the following purposes: group study rooms; the library's online catalog and databases; reserve reading room; offices; a library instruction lab; quiet reading room; collections; and general seating. Once the addition has been completed, the existing Medford Building will be scheduled for renovation, providing space for a gallery, a café, distance learning classrooms, computer classrooms, and additional space for library collections. Construction of the addition began in August 2001, with completion in the spring of 2003. The new Pickens County Headquarters Library has been a dream for many years but is now becoming reality. Construction will start October 2003 and take approximately 15 months to complete. In designing the new building we wanted this space to reflect warmth and a community feeling. We wanted to have enough space for the many activities that are now happening in a library and we wanted to have

the ability to adjust to the demands that the future will bring. We also wanted to design around a magnificent stand of mature trees and to save many of them as a park area.

Taking these thoughts into account, the additional 12,000 s.f. expansion will increase the total space to 63,000 s.f. Our new headquarters will be 51,000 heated s.f. The library exterior is very traditional enabling it to blend into the residential area next to it. The first floor is our active floor. As patrons walk into the library they can easily fan out to the specific area they are interested in visiting, (children's, adult fiction, audio video, large type, the historic room or our computer lab). Also on the first floor, our coffee shop will enhance the welcoming atmosphere of the Library. The Children's Reference desk and the Readers' Advisor Desk will be located on the first

floor to help our patrons find what they need. The second floor will be the research and study area for the library. Also on the second floor will be the Internet computers and the small and large study rooms. All of these specialized areas will be easily served from the Reference Desk. We will have study rooms on both floors for group study, tutoring or involved research. Complementing these rooms will be a large meeting room on the first floor that will seat 90 and a conference room on the second floor which will seat 12. The building itself is located on 9 acres of wooded property. A large grove of trees that are over 100 years old will be preserved for a park area. The Drs. Bruce and Lee Foundation Library of Florence County is presently under construction on Dargan Street. This impressive limestone structure was made possible due to a generous ten million dollar grant from the Drs. Bruce and Lee Foundation and a seven million dollar bond ordinance from Florence County. When finished, the 82,000 neo-classical style building will be the largest per capita public library in South Carolina. The children's room in the Drs. Bruce and Lee Foundation Library will be one of the largest children's rooms of any public library in South Carolina. Seventy-five public Internet stations will permit patrons to do research with little or no waiting. A 25-seat technology lab for training purposes will be available for use by distance education classes. The South Carolina Room will contain a climate-controlled vault. The library will also boast a state-of-the-art 250 seat meeting room. Five study rooms, with two large enough for 10-12 people will be available for use by patrons. Memorabilia from The Drs. Bruce and Lee Foundation will be featured in a permanent display. Ample parking with 272 spaces will be available for patrons. Security for materials, patrons, and staff will be enhanced with

SOLINET AND **HBCU** LIBRARY ALLIANCE COLLABORATE WITH GRANT FROM THE ANDREW W. MELLON FOUNDATION

SOLINET and the HBCU Library Alliance received a \$160,000 grant from The Andrew W. Mellon Foundation for a collaborative project to assess needs and develop a program to increase the effectiveness and visibility of libraries at the nation's Historically Black Colleges and Universities. The 12-month project will promote the role of the librarian on each campus and advocate for total integration of libraries into campus programs for teaching and learning.

With the support of The Andrew W. Mellon Foundation and SOLINET, the HBCU Library Alliance will identify what it means for a library at an HBCU to be integrated into teaching and learning processes and determine what HBCU libraries need to be able to do this effectively; gather input from the HBCU community and the academic library community about the role of the library in teaching and learning; and develop an educational program that will improve the skills, knowledge, and ability of HBCU librarians to enable them to integrate their libraries more effectively into their institutions' teaching and learning missions.

HBCU libraries serve as unique and indispensable gatekeepers for history, culture, and the African-American experience. Created by the deans and directors of these libraries after an historic meeting in October 2002, the Alliance seeks to ensure excellence in HBCU libraries through the development, coordination, and promotion of programs and activities to enhance members' collections and services. Current Steering Committee members are Loretta O'Brien-Parham, Director of the Harvey Library at Hampton University, VA; Janice Franklin, Director of the Library and Learning Resource Center at Alabama State University; Tommy Holton, Dean of Libraries at Dillard University, LA; Emma Bradford Perry, Dean of Libraries at Southern University and A&M College, LA; and Elsie Stephens Weatherington, Dean of Library and Technology Services at Virginia State University.
