Giuliana BERTIPAGLIA: Holds a doctorate from the University of Milan, where she presented a dissertation entitled "Ossian e Cesarotti." Teaches English in a primary school near Milan.

Julian Meldon D'ARCY: Associate Professor of English at the University of Iceland, Reykjavik. Has published several articles in his special field of Scottish literature, in particular on Lewis Grassie Gibbon and Sir Walter Scott. His book, *Scottish Skalds and Sagamen: Old Norse Influence on Modern Scottish Literature*, was nominated for a Saltire Society literary award in 1997.

Attila DÓSA: Graduated from Kossuth University, Debrecen, Hungary. Read English as a Soros-FCO Scholar at St. Anne's College, Oxford. Now completing a PhD thesis on Douglas Dunn at the University of St. Andrews.

Rodney Stenning EDGECOMBE: Associate Professor of English at the University of Cape Town. Took an MA at Rhodes University, Grahamstown, South Africa, and a PhD at Trinity College, Cambridge. Has published books on Herbert, Crabbe, Gray, Leigh Hunt, Keble, Newman, Patrick White, Muriel Spark, Richard Wilbur, and Howard Nemerov. Currently researching the poetry of Edwin Morgan.

Warren FOX: Received PhD in English literature from the University of California, Irvine. Currently pursuing a J.D. degree at the University of California, Berkeley.

Karin FUOG: Holds BA and MA from the University of Alberta in Edmonton, and a PhD from the University of Michigan, Ann Arbor, with a dissertation on *The Kingis Quair*. Secondary interest in popular culture, especially science fiction, where she examines the themes of Utopia and feminism. Has taught courses on the literature of the Middle Ages and science fiction at Eastern Connecticut State University.

Arnold Clayton HENDERSON: Taught English at the University of California, Berkeley, and Rutgers, before changing career to editor. Now resuming medieval studies and teaching occasionally at Rider University. Author of *Moralized Beasts: The Development of Medieval Fable and Bestiary* (1998), and is co-author of *Chaucer and Augustan Scholarship* (1970).

Kaye KOSSICK: Teaches women's writing, nineteenth-century literature and contemporary poetry at the University of Northumbria at Newcastle. Has published articles on John Clare and Gerard Manley Hopkins. Currently working on a multi-volume edition of laboring-class and vernacular poetry.

Scott A. McLEAN: Teaches at the University of Guelph, where he was active in the development of the Scottish Studies Program. Has also taught at Queen's University International Study Centre in East Sussex. General Editor (1991-1998) of *Scottish Tradition*. Has published *From Lochnaw to Manitoulin: A Highland Soldier's Tour Through Upper Canada* (1999), and is at work on a study of the Scottish-Canadian pioneer poet and journalist, William Wye Smith.

Cristie L. MARCH: Received her doctorate in English Literature from the University of North Carolina, Chapel Hill. Teaches at Drexel University. Research on contemporary Scottish literature includes work on A. L. Kennedy, Janice Galloway, Alasdair Gray, Duncan McLean, and Alan Warner. Currently writing a book on contemporary Scottish novelists.

A. A. MARKLEY: Assistant Professor of English at Penn State University, Delaware County. Has published essays on Tennyson and the literature of Greece and Rome, on the poetry of Dante Gabriel Rossetti and William Morris, and on the fiction of Mary Shelley. Is co-editing with Gary Handwerk two editions of the novels of William Godwin.

K. M. NEWTON: Professor of English at the University of Dundee. Publications include *George Eliot Romantic Humanist: A Study of the Philosophical Structure of her Novels* (1981); *In Defence of Literary Interpretation: Theory and Practice* (1986); and *Interpreting the Text: A Critical Introduction to the Theory and Practice of Literary Interpretation* (1990).

Sharon PRIESTLEY: Graduated from the University of Nevada, Reno. Presently resides in Cambridge where she teaches English Literature for the Board of Continuing Education of the University of Cambridge. Also teaches for the University of Maryland's European Division. Recently presented a paper on James Boswell at a meeting of the British Society for Eighteenth-Century Studies.

Chris RAVENHALL: Teaches part-time in the Department of English Studies at the University of Strathclyde, and is also an Associate Lecturer with the Open University in Scotland. Currently researching the work of Scottish female playwrights. Has been working for over ten years as a freelance playwright and director with community theater companies in Central Scotland.

Dietrich STRAUSS: Studied at the universities of Marburg/Lahn, Frankfurt, Aberdeen and Edinburgh, receiving the D. Phil. from the University of Frankfurt. His dissertation, entitled *Die erotische Dichtung von Robert Burns*, was published in 1981. In addition to teaching at the Gymnasium level, was part-time lecturer on Scottish Language and Literature at the University of Frankfurt and the University of Mainz, Germersheim. Lectured and published studies on Burns and medieval Scottish literature. Strauss died in 1999.

Robert P. WINSTON: Professor of English at Dickinson College, Carlisle, PA. Specializes in American Literature before 1914, especially the development of the early American novel. Has published articles on early American Literature as well as detective fiction. Co-author, with Nancy C. Mellerski, of *The Public Eye: Ideology and the Police Procedural* (1992).
