Donald CAMERON: M.A., Berkeley; Ph.D., London. At present Associate Professor at the University of New Brunswick. Prior to this he was a post-doctoral fellow at Dalhousie University where he worked on a book on structure in Scott's novels. Has published in the field of Canadian literature including a forthcoming book on Stephen Leacock.

Anna Jean MILI: M.A., Ph.D., St. Andrews. Professor Emeritus, Mount Holyoke College. Co-editor of Medieval Drama section for the new Well's Manual of Middle English; contributing editor to biographical volume of Collected Works of John Stuart Mill (in preparation). Publications include: Mediaeval Plays in Scotland (1927) and various articles on Lindsay's Satyre and other aspects of medieval drama; The South English Legendary, EETS (1956) (with C. D'Evelyn); John Mill's Boyhood Visit to France (Toronto, 1960), and several J. S. Mill articles.

William MONTGOMERIE: Born in Glasgow. Graduated M.A. at Glasgow and Ph.D. at Edinburgh. He published Via and Squared Circle, both books of verse; contributed an essay to New Judgments: Robert Burns, which he edited; and with his wife edited Scottib Nursery Rbymes, Sandy Candy (traditional folk rhymes), and Well at the World's End (Scottish folk tales). He has contributed poems, short stories, and articles to many publications.

Timothy G. A. NELSON: Holds a lectureship in English at the University of New England, Armidale, Australia. The university recently granted him a period of nine months' study leave in England and Italy, which he spent following up research interests in sixteenth century literature, especially the work of Sir John Harington of Kelston. He has had an article on Harington accepted by SP.

Ronald L. TROWBRIDGE: Ph.D., University of Michigan. At present Assistant Professor at Eastern Michigan University. Currently revising dissertation, entitled "The Echoes of Swift and Stern in the Works of Thomas Carlyle," for publication.
