NOTES ON CONTRIBUTORS

Kirstie Blair, FRSE, is Professor of English, University of Strathclyde. Following earlier work in Victorian poetry and religion, her research has focused on working-class poetry, including an anthology *The Poets of the People's Journal: Poetry in Victorian Scotland* (2016), a monograph *Working Verse in Victorian Scotland: Poetry, Press, Community* (2019: Saltire Society Book of the Year and Saltire Society Research Book of the Year), and a large multi-year AHRC-funded project on literature and industrial heritage.

Alison Chapman is Professor of English at the University of Victoria, Canada, specializing in nineteenth-century literature and culture. Recent publications include *Networking the Nation: British and American Women Poets and Italy, 1840-1870* (Oxford University Press, 2015), and an edited volume on the *Literary 1870s*, forthcoming from Cambridge in 2023. Currently she is PI for the SSHRC-funded Digital Victorian Periodical Poetry Project (<https://www.dvpp.uvic.ca>).

Koenraad Claes is a Lecturer in English Literature at Anglia Ruskin University, with a particular interest in long-nineteenth-century periodical history, the British Fin de Siècle, and representations of political conflict in Romantic-era novels and narrative poetry. He is the author of *The Late-Victorian Little Magazine* (Edinburgh University Press, 2018), and serves as Biographies Acquisitions Editor for *Yellow Nineties 2.0* and as an editorial board member for the *Journal of Victorian Culture*.

Matthew Creasy (guest editor) is Senior Lecturer in English Literature, University of Glasgow. As well as leading research projects “Decadence and Translation” (AHRC) and “Scottish Cosmopolitanism at the Fin de Siècle” (RSE), he has published on Modernism, Decadence and periodicals. His critical edition of Symons’ *The Symbolist Movement in*

Literature appeared in 2014, and he is currently completing a critical edition of George Moore's *Confessions of a Young Man*.

Linda K. Hughes is Addie Levy Professor of Literature at TCU, specializing in historical media studies; gender and women's studies; and transnationality, including transatlanticism. Her most recent monograph is *Victorian Women Writers and the Other Germany: Cross-Cultural Freedoms and Female Opportunity* (Cambridge University Press, 2022) and she is co-editor, with Sarah R. Robbins and Andrew Taylor, of *Transatlantic Anglophone Literatures 1776-1920: An Anthology* (Edinburgh University Press, March 2022).

Tony Jarrells (*joint editor*, SSL) teaches at the University of South Carolina. He is past chair of the MLA Executive Committee for Scottish Literature, and a former visiting fellow in the Institute for Advanced Studies in the Humanities, University of Edinburgh. Recent publications include essays in *The International Companion to John Galt* and *Walter Scott at 250: Looking Forward*.

Lorraine Janzen Kooistra, FRSC, is Professor Emerita of English and Founding Co-Director Emerita of the Centre for Digital Humanities at Toronto Metropolitan University (formerly Ryerson University). She has published widely in Victorian illustration studies and book history, little magazines and fin-de-siècle print culture, and digital scholarship and remediation. Her ongoing digital project, *Yellow Nineties 2.0*, is generously supported by the Social Sciences and Humanities Research Council of Canada.

Murdo Macdonald, FRSA, HRSA, is Emeritus *Professor* of History of Scottish Art, University of Dundee. His books include *Scottish Art* (Thames and Hudson, 2000, new edition 2021), *Patrick Geddes's Intellectual Origins* (Edinburgh University Press, 2020), and *Ruskin's Triangle* (Ma Bibliothèque, 2021).and the co-edited volume *Patrick Geddes: By leaves We Live. Edinburgh–Yamaguchi 2004* (Yamaguchi Institute of Contemporary Art, 2005). He is an honorary member of the Royal Scottish Academy, an honorary fellow of the Association for Scottish Literature, and a trustee of the Scottish Centre of Tagore Studies.

Alex Murray is Senior Lecturer in British and American Literature, Queen's University, Belfast. His books include a monograph *Landscapes of Decadence: Literature and Place at the Fin de Siècle* (2016), and the edited volumes *Decadent Poetics: Literature and Form at the British the Fin de Siècle* (2014) and *Decadence: A Literary History* (2020).

Patrick Scott (*joint editor, SSL*) is Distinguished Professor of English, emeritus, University of South Carolina, and honorary research fellow in the Centre for Robert Burns Studies, University of Glasgow. Recent publications include *Robert Louis Stevenson: A Documentary Volume* (2021).

Michael Shaw (*guest editor*) is Lecturer in Scottish Literature at the University of Stirling, and a former G. Ross Roy medallist. He is the author of *The Fin-de-Siècle Scottish Revival: Romance, Decadence and Celtic Identity* (Edinburgh University Press, 2020) and editor of *A Friendship in Letters: Robert Louis Stevenson & J. M. Barrie* (Sandstone Press, 2020).
